Mr. Weaver has knowledge in this area. Dakota spoke to the BAR exploring the Insurance policies. Suggested that units ask for the complete policy to explore what exclusions exist. All kinds of exclusions have been identified, from the weapon is made outside the us, serial numbers, social media postings Horse and artillery on the field, etc could be excluded in the coverage.
